The Children's Society: Children in England among the unhappiest in the world with school

Children in England are unhappier with their school life than those in almost every country featured in a major new international survey by The Children's Society, with more than half a million 10 and 12-year-olds having been physically bullied each month, causing huge damage to their happiness, and with many more feeling left out.

Poor beginnings: health inequalities among young children across England

This report is based on official data published by Public Health England. It looks at four key measures of young children's health and well-being - obesity, tooth decay, accidental injury and 'school readiness'. The report provides a clear picture of the health of children under five years old living in England and shows how growing up in different areas of the country has a dramatic effect on their lives.

Young children's and families' experiences of services aimed at reducing the impact of low-income: participation work with children and families

This report presents the findings of a qualitative research and participation project that explores the views and experiences of children under five years, and their parents, of services important for reducing the impact of low-income. The study was conducted by the National Children's Bureau and commissioned by the Office of the Children's Commissioner.

<u>Changing the odds in the early years: a discussion paper on tackling poverty in the early years</u> This report from the Children's Commissioner presents research into local services that prevent poverty during the early years Access here

Young People's Health Partnership Briefing: Substance Misuse (July 2015)

Addaction (with other members of the Young People's Health Partnership, a consortium of organisations working with the Department of Health, Public Health England and NHS England) has produced this briefing about young people's substance misuse and how local services and commissioners can respond to this issue.

SEN and disability in the early years toolkit

4Children and the Council for Disabled Children (CDC) have produced a toolkit for SEN and disability in the early years. Each section of the toolkit provides a briefing on a particular aspect of the SEN and disability reforms as they apply to early years providers. The determinants of health inequities experienced by children with learning disabilities

This report summarises current scientific knowledge about the determinants of health inequities experienced by children with learning disabilities in the UK. Recommendations targeted at national and local government are included in the report and focus on three key actions: reducing child poverty; reducing exposure to specific hazards; and building resilience. Obesity: prevention and lifestyle weight management in children and young people

This NICE quality standard covers a range of approaches at a population level to prevent children and young people aged under 18 years from becoming overweight or obese, including interventions for lifestyle weight management. Report here

Smoking, drinking and drug use among young people in England - 2014

This report contains results from an annual survey of secondary school pupils in England in years 7 to 11 on smoking, drinking and drug use. New areas included in the survey for the first time were e-cigarettes, waterpipe tobacco, legal highs and energy drinks. Report here

Associations between food outlets around schools and BMI among primary students in England: a crossclassified multi-level analysis

This study examines associations between food retailing and BMI among a large sample of primary school students in Berkshire, England. There was little evidence to suggest that food retailing around schools influences student BMI. There is some evidence to suggest that fast food outlet densities in a child's home neighbourhood may have an effect on BMI, particularly among girls, but more research is needed to inform effective policies targeting the effects of the retail environment on child obesity. Five million people at high risk of developing Type 2 diabetes

Five million people in England have blood sugar levels indicating a high risk of developing Type 2 diabetes. The <u>report on non-diabetic hyperglycaemia</u>, published by Public Health England on behalf of the <u>NHS Diabetes Prevention Programme (NHS DPP)</u>, gives the most up to date estimate of how many people are at risk of developing the condition. The NHS DPP will support those on the point of developing the condition, by helping them lose weight and become more active.

What explains the growth in 'never-worked' households? (Joseph Rowntree Foundation) here The number of homes where no one has ever worked has doubled in little more than a decade. But is this a sign of growing 'welfare dependency' or the result of other factors? This report looks at the characteristics of 'never-worked' households and considers the possible reasons for the increase. It finds that most never-worked household are lone parent households and younger single people; there is little or no evidence of a problem of 'intergenerational worklessness'.

Youth Select Committee publish young people's mental health report

The report, launched as part of Parliament Week, concludes that mental health services for young people are critically underfunded and that much work is needed to break down the stigma associated with mental health problems.

New children's Body Mass Index (BMI) trends report

PHE has published the latest National Child Measurement Programme (NCMP) trends report, which shows changes in the BMI of children in state maintained primary schools in England between 2006/07 and 2013/14. The report shows that obesity is stabilising in Reception (age 4-5 years) girls and there is a downward trend in obesity in Reception boys. In Year 6, however, there is a significant upward trend in obesity among both boys and girls with the highest average increase per year in girls of this age. In both Reception and Year 6, inequalities in obesity are widening between the most deprived and least deprived children.

A new home for public health services for children aged 0-5: a resource for local authorities

This briefing for officers will help councils deliver their new statutory responsibility for commissioning children's public health services for children aged 0-5. It has information about the transfer and the opportunities to join up public health functions for children aged 0-19.

Children looked after in England (including adoption and care leavers) year ending 31 March 2015

This statistical first release provides information about looked-after children at both national and local authority levels for the financial year 2014 to 2015

Guidance: What works in schools to increase physical activity: briefing

A briefing for head teachers, college principals, staff working in education settings, directors of public health and wider partners.

Health behaviour in school-aged children England national report 2014

This report presents the findings for England from the 2014 Health Behaviour in School-aged Children (HBSC) World Health Organization (WHO) collaborative study. It provides an up to date view of adolescent health and well-being in England, and provides an overview of trends in these areas spanning more than a decade (2002-2014).

Proportion of children in out-of-work benefit households measure for 2014

Statistics on the number and proportion of children living in out-of-work benefit households for each local authority in England.

Supporting children, young people and families and communities to be safer, healthier and to reduce youth crime. This pathway provides guidance to school nurses and youth justice professionals working with young people who are in the youth justice system or at risk of being involved. It sets out the rationale for effective partnership working and pulls together the core principles to help local areas develop their own local frameworks to support effective working.

Measuring mental wellbeing in children and young people

This guide to measuring the mental wellbeing of younger populations aims to support local joint strategic needs assessments (JSNAs) and the commissioning of interventions to improve the mental wellbeing of local children and young people. The technical appendix has measures to quantify mental wellbeing and its determinants, information on using the measures and links to examples of evidence based practice.

Helping school nurses to tackle child sexual exploitation

This pathway is designed to clarify the role of the school nursing service regarding child sexual exploitation.

<u>The contribution of further education and skills to social mobility - BIS research paper 254</u> This review of published research from government, academics and think tanks investigates how taking part in further education helps people get better jobs and wages. It also looks at the effects further education has on the prospects for the children of learners.
