## Wirral's Health & Wellbeing Board response to correspondence received from NHS England related to Wirral's Pharmaceutical Need Assessment

Type of change: Consolidation – closure of one site

It is the view of Wirral Health & Wellbeing Board that this change to the availability of pharmaceutical services is relevant to the granting of applications referred to in the NHS Act 2006 and in the subsequent NHS (Pharmaceutical and Local Pharmaceutical Services) Regulations 2013, and the HWB is satisfied that a revised PNA would be a disproportionate response. Wirral Health & Wellbeing Board decision is that this closure does not leave a gap in essential pharmaceutical services in the area therefore please note the consolidation of the following pharmacies.

Please note the consolidation of the pharmacies at Parkfield Medical Centre, Sefton Road, New Ferry, Wirral, CH62 5HS (the remaining site) and 20 Bebington Road, New Ferry, Wirral, CH62 5BQ (the closing site) will take effect from 12<sup>th</sup> July 2021 and the pharmaceutical list for the area of Wirral Health and Wellbeing Board will be amended with effect from that date.
